

Removal activities

Objectives

In case of discriminatory acts or behaviours, contributes to repairing of the situation through immediate removal of the acts of prejudice already effected

Actions

Offers legal assistance in case of legal or administrative procedures, by accompanying the victim through the action taken

Helps with information, news and observations, both written and oral during the legal procedure

Carries out autonomous investigations to verify the existence of discriminatory behaviours

Carries out informal reconciliations

• I LEVEL: collects reports and researches useful information for solving problems right away


• II LEVEL: in case it is not possible to solve the problem right away, it forwards the case to UNAR to be solved with supervision of an expert

Discrimination events and relevant events as % of total: 2004-2011




Trend in relevant events 2005-2011: moving indices and moving average




